D.E.R. 669-20 Solid Epoxy Resin can also be used as a binder in ambient curing systems in combination with isocyanate cross-linkers. Finishes made from D.E.R. 669-20 Resin are suitable for metal decoration, interior and exterior can coatings, tube and drum linings, coil primers and many other industrial applications.
