The low coalescent demand of RHOPLEX<sup>™</sup> 585 allows the formulator to meet the 50g/VOC regulations while still maintaining some freeze thaw stability. Due to its 100% acrylic composition, RHOPLEX<sup>™</sup> 585 offers good exterior durability.
