HAZARDOUS INGREDIENT TOXICITY DATA

Based on literature and actual test data, dibutyltin dilaurate (DBTL) has acute oral LD50 values ranging from less than 2000 to >2000 mg/kg. The acute dermal LD50 (rat) is >2000 mg/kg. Dibutvltin dilaurate (DBTL) may cause severe skin irritation. This substance may cause skin sensitization (allergic skin reactions). Repeated oral administration of DBTL has caused liver damage and death in animals. Neurotoxicity has also been observed in animals after oral exposure. DBTL may impair fertility, may cause harm to the unborn child and is suspected of causing genetic defects. Tumour formation was not observed in a 2-year chronic study conducted with mice and rats with a structural analogue. Organotin compounds are suspected of causing immunosuppressant effects.

The toxicological properties of acrylated resin have not been fully investigated. Direct contact with this material may cause moderate eye and skin irritation.
